



# What is the SR&ED Program

Tax incentive program to encourage new product, new process and improved process development IN CANADA.

Provides refundable tax credits from 35% to 70% of dollars spent from most CCPC's

Equivalent program in provinces provides an additional 10% to 35% (province dependent)



# WHY SR & ED Alberta


# **SR&ED** is all about **INNOVATION**

If you believe that what makes you special as a company is that your products are BETTER than your competitors, or cheaper because you are MORE EFFICIENT, then, you probably got that way by doing SR&ED.

- Increase in Overtime to Volume Ratio
- Balding or Graying of Management Staff
